Subject: Community Development Block Grant (CDBG) Applications for PY2020

The City of Idaho Falls is in the process of developing their PY2020 Annual Action Plan for the PY2020 CDBG funding cycle.

The FY2020 CDBG application cycle was completed as of January 11, 2020 with a total of \$437,796 in grant applications submitted to the Grant Administrator.

After a series of continuing resolutions, the federal budget was passed. On February 14, 2020, Housing and Urban Development (HUD) announced PY2020 CDBG allocations to Entitlement Communities. The City of Idaho Falls is expected to receive an allocation of \$425,099.

In order to move forward with the process and submit the FY2020 CDBG Annual Action Plan to HUD on or before June 30, 2020, a public hearing has been scheduled for April 9, 2020 at 7:30 pm. The public hearing will be held during the regularly scheduled Council Meeting at the City Annex building 680 Park Ave in Idaho Falls.

Public comments will be taken from April 10, 2020 through May 10, 2020.

A Council Work Session will be held May 11, 2020 to discuss projects and activities recommended for CDBG funding to be submitted to HUD for final approval.

A Council Meeting will be held May 14, 2020 at 7:30 pm in the Council Chambers and a Resolution of Mayor and Council approved projects and activities will be announced.

Council approved projects and activities are a portion of the draft PY2020 CDBG Annual Action Plan that will be submitted to HUD for final approval.
