Thank you for your interest in the 2020 IFPD Citizen's Police Academy. The Citizen's Police Academy is intended to provide Idaho Falls community members with an inside look at the Idaho Falls Police Department and police activity in Idaho Falls. Classes are designed to be engaging, with an exciting and interesting topic covered each time the class meets.

The goals of the class are to build relationships between IFPD and the Idaho Falls community, to provide education about law enforcement, and to allow community members to meet the men and women who serve the community at the Idaho Falls Police Department. The IFPD CPA is ideal for individuals interested in gaining a greater understanding of law enforcement and about IFPD, for those exploring a career in law enforcement, and for those interested in joining the Citizen's Watch Patrol.

The 2020 IFPD CPA is scheduled to begin on Wednesday, September 16, 2020 and end October 28, 2020. Classes are held each week on Wednesday evenings, with the exception of two weeks when the class will be held on Saturday. Accepted applicants will be provided with a complete class schedule upon acceptance to the Academy. Class members are expected to make every effort to attend all class sessions. Any class member who is unable to attend a class session is asked to promptly notify the class host.

Due to COVID-19, class members may be asked to wear a face mask and/or to adhere to social distancing guidelines during class time/activities in order to ensure the health of instructors and class members. Expectations and updated information will be provided to applicants prior to the start of the Academy.
